Notify all award recipients, nominators, and Headquarters of the committee's decision for each award. 3. Identify opportunities for awards outside of the Fraternity, identify potential nominees, and facilitate nominations. Examples include PFA, APhA, ASHP, and local pharmacy organizations. 4. Determine the need for additional collegiate awards and recognition. 5. Submit call for nominations to the Alumni News, LinkS, and the Blue and Gold Triangle editors, as well as the Communications Committee chair based on the April 30th deadline for the Vanguard, Distinguished Young Pharmacist, Advisor, Distinguished Service Citation, and Award of Merit. 6. Assist in the planning of the Awards presentations at Convention and preside over that program. 7. Provide interim report to Grand Council. 8. Submit annual Convention report.
Section 2: Progress to Date Activities Specific to Job Description	<ol style="list-style-type: none"> 1. Awards were promoted throughout March and April 2022 in order to encourage members to submit nominations. 2. In late May 2022 the committee selected the following recipients for the 2022 Fraternity Awards: Stacy Taylor- Advisor Award, Dixie Leikach-Award of Merit, Amanda Zahn-Collegiate of the Year, Nicole

Pezzino-Distinguished Young Pharmacist, Mary Beth O'Connell-Vanguard Leadership Award, and Jenny Brandt (by recommendation of Grand Council) for Distinguished Service Citation.

3. Outside Awards: Letitia Warunek was nominated for the Prescott Leadership Award. Dixie Leikach was nominated for the Pharmacist Mom's Group Independent Pharmacist of the Year Award. We were pleased to learn that Dixie Leikach was selected as the recipient of her award. Patti Clancy Kienle was nominated for the PFA (Professional Fraternity Association) Career Achievement Award. Dixie Leikach was nominated for PFA's Career Achievement Award. Pharmacy Times promotes an annual Next Generation Pharmacist Award, with an ultimate winner among all categories receiving a feature on the cover of Pharmacy Times magazine. In this set of awards, Patti Kienle was nominated for the Lifetime Leadership Award and Nicole Pezzino was nominated for the Pharmacy Educator award.

4. There has been some discussion of additional fraternity collegiate awards being established for more opportunities to recognize collegiate members beyond the Collegiate of the Year award. This discussion is still pending based on the success and feedback from the additional newly established collegiate chapter awards, but will continue to be considered as a potential next project.

5. Awards were promoted and advertised throughout March and April in preparation for the opening of applications March 15th-April 30th.

6. Last summer's virtual awards program in 2021 consisted of video excerpts compiled via iMovie, and this format was saved in order to utilize for future programs and virtual recognition if needed. This year we will be
